SCOPE OF SERVICES

1.0 INTRODUCTION

It is expected that the Contractor shall partner closely with Embassy Facilities Management Department for the successful execution of the project.

2.0 TECHNICAL SPECIFICATIONS

 - 2.3 Carry out periodic emptying and cleaning of the facilities and dump sludge in accordance the National Environment disposal requirements

 - 2.5 All vehicle drivers and equipment operators shall have proper licensing and training applicable to the specific equipment.

2.6 The work shall be executed in a diligent manner in accordance with a negotiated firm fixed price and performance period. The period of performance for project completion shall be in accordance with Paragraph 7.

2.7 The Contractor shall address the impact of the consequent disruption and provide for a continuing level of operation of the office functions caused by the proposed construction.

2.8 The Contractor shall be required to prepare reports, bill of materials, quality control schedules and construction costs. These documents shall provide the necessary interfaces, coordination, and communication among the Embassy, contractor, and special disciplines for the delivery of a completed construction project.

3 CONTRACT ADMINISTRATION

- 3.2 The Contractor shall not conduct any work that is beyond this Statement of Work unless directed in writing by the Facilities Manager (FM) or Contracting Officer [CO]. Any work done by the Contractor beyond this SOW without direction from the CO will be at the Contractor's own risk and at no cost to the Embassy.
- 3.3 The Contracting Officer shall provide a Notice to Proceed [NTP] to the Contractor. No work shall be initiated until the NTP is issued by the CO.
- 3.4 The Embassy has the right to inspect and test all services called for by the contract, to the extent practicable at all times and places during the term of the contract. Facility Management Department may perform quality assurance inspections [QAI] and tests during construction to confirm the work is installed according to the Statement of Work.

4 RESPONSIBILITY OF THE CONTRACTOR

- 4.2 The Contractor shall be responsible for the professional quality, technical accuracy, and the coordination of all destruction, construction and other services furnished under this contract. The Contractor shall, without additional compensation, correct or revise any errors or deficiencies in its construction and other services.
- 4.3 The Contractor shall identify a Project Site Manager who shall be responsible for the overall management of the project and shall represent the Contractor on the site during all work. The fluent English speaking and reading Project Site Manager shall be approved by the COR.
- 4.4 The Contractor is responsible for site safety and shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety and similar matters. All contractor employees shall wear closed toe site appropriate footwear at all times. The Contractor shall promptly report all accidents resulting in lost time, disabling, or fatal injuries to the COR.

5 CONSTRUCTION REQUIREMENTS

- 5.2 All equipment including but not limited to Cranes, Hoists, Vehicles, Loaders, Powered Equipment, Hand Power Tools, Ladders, Chutes, Scaffoldings, and Ramps on the worksite shall be maintained and operated in accordance with the manufacturers specifications and guidelines.
- 5.3 Furnish and maintain temporary ramps, scaffolds, hoists or chutes as required for proper execution of the works.
- 5.4 Provide overhead protection to adjacent buildings.
- 5.5 Restrict debris removal the Embassy approved area.
- 5.6 Restrict location of construction cranes to areas as approved by the US Embassy.
- 5.7 The contractor shall ensure equipment and construction methods comply with applicable local laws and regulations.
- 5.8 All materials and equipment incorporated into the project shall be new. The Contractor

- shall transport and safeguard all materials and equipment required for construction.
- 5.9 Obtain quality primary materials from manufactures that have successfully produced similar product for at least ten years.
- 5.10 The Contractor will be permitted to use the area within the compound for operation of his construction equipment and temporary facilities. The Contractor is responsible for obtaining any additional off compound storage areas required.
- 5.11 The Contractor shall be responsible for connection of temporary utilities to existing utilities including water, power, and telephone lines. All temporary connections to local water and power shall be coordinated with the US Embassy.

6 CRITERIA

- 6.2 The contractor shall construct the temporary structure project in accordance with U.S. codes and standards. Facility Management Department will review and comment on the Contractor’s submissions using the following codes and standards:

7.4 The Contractor shall commence work under this contract promptly, execute the work diligently, and achieve final completion and acceptance of the roof replacement project including final cleanup of the premises within the contract period specified.

8 CONTRACTOR CLEARANCES

- 8.2 This is an unclassified project. The work to be performed under this contract requires that the Contractor, its employees and sub-contractors submit corporate, financial and personnel information for review by the Embassy. Information submitted by the Contractor will not be disclosed beyond the Embassy.
- 8.3 The Contractor shall provide to the COR via email 24 hours prior to required access all necessary information including but not limited to:

9 **QUALITY CONTROL**

- 9.2 Facility management department has the right to inspect and test all services, to the extent practicable at all times and places during the work. Facility management may perform full time quality assurance inspections (QAI) and tests during construction to confirm the work is installed according to construction documents.
- 9.3 Maintain quality control over suppliers, Manufacturers', products, services, site conditions and workmanship to produce work of specified quality.
- 9.4 The Contractor shall be responsible for the following construction inspections and tests:
 - 9.4.1 Compressive and tensile strength of steel.
 - 9.4.2 Concrete strength

10 **STORAGE OF MATERIALS**

- 10.2 Proper storage of Materials is the sole responsibility of the Contractor. Protect all Materials susceptible to moisture including, but not limited to all roll goods, insulation, wood, and dry wall boards in above ground water tight storage. Keep all labels intact and legible clearly showing the product, manufacturer and other pertinent information.
- 10.3 Store materials in site. Cover and protect materials subject to damage by weather, including transit. Stored materials shall be available for inspection.
- 10.4 Store flammable and volatile materials/liquids in sealed containers located a minimum of 20feet from existing buildings.
- 10.5 Liquid Products shall be delivered sealed in original containers.

11 **TEMPORARY FACILITIES**

- 11.2 Temporary Water:
 - 11.2.1 A temporary connection to the chancery water supply will be run by the contractor over the existing embassy wall.
 - 11.2.2 All work shall comply with International Building Code (IBC) and National Water and Sewage Corporation (NWSC) regulations.
- 11.3 Temporary Sanitary Sewer:
 - 11.3.1 Temporary connection to the Ggaba road sanitary sewer line will be installed by

the contractor and be used as necessary.

11.3.2 All work shall comply with the IBC and NWSC regulations.

11.4 Temporary Storm Sewer:

11.4.1 Contractor shall connect to the city storm sewer system as necessary, all necessary care shall be taken to prevent erosion of soils and to not allow contamination to enter the storm sewer system.

11.4.2 All work shall comply with the IBC and NWSC regulations.

11.5 Temporary Electricity:

11.5.1 Temporary power for construction and lighting shall be provided by the US Embassy.

11.5.2 Temporary power shall be drawn from spare circuit breakers in the generator room and transmitted over the perimeter wall via NFPA 70 (U.S. Electrical Code) or compliant (whichever is more restrictive) wiring to a temporary power distribution panel.

11.5.3 All electrical circuits on the property shall be protected by ground fault circuit protection.

11.5.4 All wiring shall comply with NFPA 70 or IBC (whichever is more restrictive)

11.5.5 The Contractor shall notify the Embassy a minimum of two days prior to each interruption of Mechanical or electrical services in the building. The interruptions shall be only at such times and for lengths of time as approved by the US Embassy.

11.5.6 Provide all necessary temporary wiring (in conduits) extensions and temporary lighting devices.

12 PROJECT PROCEDURES

12.2 The Embassy will be occupying the adjacent premises during the construction period.

12.3 The Contractor shall conduct his operations so as to ensure least inconvenience to the Embassy operations.

12.4 Contractor shall take precaution to avoid excessive noise or vibration during construction.

12.5 Contractor shall provide a safety and health plan to ensure effective implementation.

13 DEFECTS LIABILITY PERIOD

The Contractor shall guarantee integrity of Workmanship for a period of six Months from date of Substantial completion

For line items covered by the WTO GPA, the Government will evaluate offers of U.S.-made or designated country end products without regard to the restrictions of the Buy American statute. The Government will consider for award only offers of U.S.-made or designated country end products unless the Contracting Officer determines that there are no offers for such products or that the offers for such products are insufficient to fulfill the requirements of the solicitation.

(h) *Certification Regarding Responsibility Matters (Executive Order 12689)*. (Applies only if the contract value is expected to exceed the simplified acquisition threshold.) The offeror certifies, to the best of its knowledge and belief, that the offeror and/or any of its principals--

(1) Are, are not presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any Federal agency;

(4) Have, have not, within a three-year period preceding this offer, been notified of any delinquent Federal taxes in an amount that exceeds \$3,500 for which the liability remains unsatisfied.

(i) Taxes are considered delinquent if both of the following criteria apply:

(A) *The tax liability is finally determined.* The liability is finally determined if it has been assessed. A liability is not finally determined if there is a pending administrative or judicial challenge. In the case of a judicial challenge to the liability, the liability is not finally determined until all judicial appeal rights have been exhausted.

(B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. §6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. §362 (the Bankruptcy Code).
