1. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is to for Banking Services.
- B. The contract will be for a one-year period from the date of the contract award, with **four** one-year options.

The offeror shall provide full-time bank cashier at the U.S. Embassy Building (the "Cashier"). The Cashier will provide teller services including currency exchange and normal commercial banking services to the U.S. Embassy during the normal business hours and the bank counter will be open during the hours stated below.

Monday - Thursday- 9:00 to 15:30
Friday - 9:00 to 12:00 noon

The cash office will be closed on all U.S. and local holidays as published in the annual Mission Holiday Notice and on all Embassy approved/administered leave days.

The cashier is an employee of the bank, and the bank assumes all responsibility for salary and benefits, security to and from U.S. Embassy premises, etc.; however, while on the U.S. Embassy premises, the cashier will adhere to the same standards of conduct required of all U.S. Embassy employees (which shall have been communicated with sufficient advance notice to the offeror and cashier to enable full compliance).

- C. Automated Teller Machine (ATM) Services: Install, manage, operate, and maintain not more than two ATMs and related equipment in designated space inside the U.S. Embassy compound in accordance with the license agreement for ATM services. The ATM(s) provided must be less than five (5) years old when installed on the U.S. Embassy compound. The bank will ensure an upgraded efficient ATM is availed within the stipulated lifecycle. Any additional ATM required in light of increased operations and users on the premises shall be discussed.
- D. Provision of USD accounts to all interested U.S. Embassy employees. These would ideally be funded from their offshore accounts. Employees will access these funds using USD debit cards.
- E. Access of funds using the ATM and this would avail both U.S dollars and local currency. The ATMs shall accept all Visa enabled cards as well as Master Card.
- F. Credit Cards for Individual U.S. Embassy Employees: Offer U.S. Dollar denominated credit cards for use by Embassy employees. These would be personal credit accounts and not guaranteed by the U.S. Embassy or the U.S. Government.

The bank shall offer U.S. Embassy staff Credit Cards denominated in Uganda Shilling. Cards will be issued to the number of U.S. government employees as required for their spending needs on travelling and entertainment. The card shall be widely accepted across the world.

- G. Checking and/or Savings Accounts for U.S. Embassy Employees: Provide personal accounts for individual employees of the U.S. Embassy. The bank shall design personal checking/savings accounts that can benefit U.S. Embassy employees.

2. THE BANK WILL BE RESPONSIBLE FOR PROVIDING THE FOLLOWING:

1. Key personnel as listed
2. Privatized cashier and disbursement services. The cashier is an employee of the bank, and the bank assumes all responsibilities for salary and benefits, security to and from the U.S. Embassy premises. The bank shall ensure the cashier adheres to the same standards of conduct as required of all U.S. Embassy employees.
3. A fulltime cashier in the U.S. Mission main office building (the cashier).
4. An intelligent automated teller machine (ATM).
5. Foreign Currency exchange services to U.S. Embassy employees with various currencies.
6. Secure transportation for the cash to and from U.S. Embassy premises.
7. A Bank-owned and secure local box for Bank owned cash and checks.
8. Appropriate insurance for all Bank-owned assets. The U.S. Embassy assumes no liability to Bank assets.
9. Bank's secure internet line and approved routing equipment.
10. Any other equipment used in the bank.

3. U.S. EMBASSY WILL BE RESPONSIBLE FOR PROVIDING THE FOLLOWING:

1. A secure Cashier Office. The bank and the designated U.S. Embassy employee (security office) will have exclusive access to the office. The office will remain locked (from within) during the hours of operation. In accordance with U.S. Government regulations a duplicate key will be locked in the designated security office.
2. Operational equipment including a telephone, electricity, office furniture.
3. A limited access (non-network) computer and printer.
4. A limited access U.S. Embassy Identification badge for the bank Cashier.
5. Such other access to U.S. Embassy premises and facilities as are necessary in the reasonable opinion of U.S. Embassy to allow the bank to perform its obligations under this contract.
6. Access to U.S. Embassy premises (with the specific purpose of attending the Cashier Office) to permit the bank to conduct checks/audits strictly on the Cashier and U.S. Embassy operations as conducted in the Cashier Office only. Checks/audits will be conducted by the bank only on any one or more of the dates which bank selects from a schedule which has been pre-agreed with the U.S. Embassy.
7. Regularly updating antivirus software and the software patches on the terminals and systems used on site by the bank and reasonable servicing of the non-network computer and printer on a quarterly basis.
8. Strict control of the local administrator computer password and submission to the bank a list of systems administrators who hold this password in accordance with current U.S. Embassy information technology policy; and

9. Restrict usage of removable external drives like memory sticks on the computer by disabling USB ports.

4. LIABILITY

Neither party to the Agreement limits its liability for:

- (a) Fraud or theft by its or its employees;
- (b) Death or personal injury caused by its proved gross negligence or that of its employees, agents or sub-contractors. as applicable;
- (c) Any regulatory losses, fines expenses or other losses arising from a breach by that Party of any law or regulation; and
- (d) A third party obtaining unauthorized access to the bank's systems, except where such access constitutes a technical breach of process which has no adverse effect on the bank systems.

Notwithstanding the aforementioned provisions:

The total aggregate liability of the bank and its respective affiliates arising from any breach under this Agreement and with regard to the arrangements contemplated hereunder will be a maximum of the fees received under this Agreement.

The total aggregate liability of the U.S. Embassy and its respective affiliates arising from any breach under this Agreement and with regard to the arrangements contemplated hereunder will be a maximum of the fees paid under this Agreement.

Neither party will be liable to the other party for any indirect or consequential loss or damage including, without limitation, any indirect loss of business or profits in each case whether arising from negligence, breach of contract or otherwise.

The parties expressly agree that if any limitation or provision, contained or expressly referred to in this section (liability) is held to be invalid under any applicable statute or rule of law it will to that extent be deemed omitted but if any party becomes liable for loss or damage which would otherwise have been excluded that liability will be subject to the other limitations and provisions set out in this section (liability).

Nothing in this section (liability) will be taken as in any way reducing or affecting a general duty to mitigate loss suffered by a party.

6. INTELLECTUAL PROPERTY RIGHTS

All intellectual property rights belonging to a party prior to the execution of this contract shall remain vested in that party.

None of the intellectual property rights in a party's trademarks and brands shall be used by the other party for any purpose without the owning party's prior written consent.

7. CONFIDENTIAL

Each party shall keep secret and treat as confidential all information obtained from the other which is either stated to be confidential or could reasonably be regarded as confidential and shall not disclose such information.

8. KEY PERSONNEL

Specific individuals assigned by the bank shall act as prime and secondary representatives of the bank on U.S. Embassy account matter. Such representations may consist of:

1. A fully trained primary and one alternate cashier in the U.S. Mission main office building (the "Cashier").
2. Customer Services Representative.
2. Account Relations Manager; and
3. Software Maintenance Technician.

The bank will periodically notify FMO's Office the names of those employees and changes. if any.

9. PAYMENT SCHEDULE:

For providing the services described in this contract, U.S. Embassy will pay fees to the bank on a quarterly basis. Any adjustment to the established rate can only be made by prior discussion and agreement between the Contracting Officer and the bank.

10. MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totalling a minimum of \$5,000. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed \$100,000 This reflects the contract maximum for this period of performance.”

12. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion. It is reflected for each performance period. The portions of the solicitation subject to VAT are: None

13. CLOSE OUT

The bank will develop and implement a FMO approved closeout plan. The closeout plan will be submitted to the FMO three months prior to the end date of the award.

14. PERIOD OF PERFORMANCE

This contract formalizes the existing arrangements in place between the parties hereto as at the date the last party signs this contract (the "Effective Date").

This contract shall be deemed to have commenced on the date of the Contracting Officer's signature on the cover page and shall continue for a term of one (01) year ("Base year"). Unless terminated in accordance with the terms of this Contract shall exercise for four further periods of one (1) year ("Option years"). Total Contract period shall not exceed five years.

The U.S. Embassy shall give written notice of its intention to renew or terminate this contract not less than three (3) months prior to the expiry of the base year or relevant renewal option.

In addition to the right to terminate stated above, this contract may be terminated by either U.S. Embassy or the bank at any time during the option year subject the terminations clause under commercial acquisition.

15. PLACE OF PERFORMANCE

Performance of this contract will be principally in Uganda at the U.S. Embassy in Kampala.

16. EVALUATION OF CONTRACT PERFORMANCE

Evaluation of the bank's performance shall be conducted in accordance with the performance standards and indicator targets set forth in in this contract. Evaluation by the FMO and the Contracting Officer (CO) will be conducted jointly and shall form the basis of the bank's performance record with regard to this contract as required in FAR Part 42.15.

17. 52.232-1 PAYMENTS (APR 1984)

The government will pay the bank, upon the submission of proper invoices, the prices stipulated in this contract for supplied delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified in this contract, payment shall be made on partial deliveries accepted by the government if ;

- i. The amount due on the deliveries warrants it; or
- ii. The bank requests it and the amount due on the deliveries is at least \$1,000.

18. CONTRACTUAL ISSUES

Contractual issues, of any nature, that might arise during the life of the contract must be handled in conformance with specific public laws and regulations (i.e. Federal Acquisition Regulation). The bank, through the FMO, shall bring all contracting issues to the immediate attention of the Contracting Officer. Only the Contracting Officer is authorized to formally resolve such issues. The Contracting Officer will be responsible for resolving legal issues, determining contract scope and interpreting contract terms and conditions. The Contracting Officer is the sole authority authorized to approve changes in any of the requirements under this contract. Notwithstanding any clause contained elsewhere in this contract, the said authority remains solely with the Contracting Officer. These changes include, but will not be limited to the following areas: scope of- work, price, quantity, technical specifications, delivery schedules, and contract terms and conditions. In the event the bank effects any changes at the direction of any other person other than the Contracting Officer. the change will be considered to have been made without authority.

Failure by the bank to report to the Contracting Officer any action by the Government considered to a change, within the specified number of days contained in FAR 52.243 7 (Notification of Changes). waives the bank's right to any claims for equitable adjustments.

20. EXECUTIVE ORDER ON TERRORISM FINANCING (FEB 2002)

assistance are to be reported. Foreign taxes by a third-party foreign government are not to be reported. For example, if an assistance program for Lesotho involves the purchase of commodities in South Africa using foreign assistance funds, any taxes imposed by South Africa would not be reported in the report for Lesotho (or South Africa).

- (vi) Any reimbursements received by the bank during the period in (iv) regardless of when the foreign tax was assessed plus, for the interim report, any reimbursements on the taxes reported in (iv) received by the bank through October 31 and for the final report, any reimbursements on the taxes reported in (iv) received through March 31.
 - (vii) The final report is an updated cumulative report of the interim report.
 - (viii) Reports are required even if the bank did not pay any taxes during the report period.
 - (ix) Cumulative reports may be provided if the bank is implementing more than one program in a foreign country.
- (c) Definitions. For purposes of this clause:
- (i) "Commodity" means any material, article, supply, goods or equipment.
 - (ii) "Foreign government" includes any foreign governmental entity.
 - (iii) "Foreign taxes" means value-added taxes and custom duties assessed by a foreign government on a commodity. It does not include foreign sales taxes.

The bank shall not discriminate against people with disabilities in the implementation of this contract and that it make every effort to comply with the objectives of the U.S. Government Disability Policies in performing this contract. To that end and within the scope of the contract, the bank's actions must demonstrate a comprehensive and consistent approach for including men, women and children with disabilities.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. 652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
